2021 Alabama Partner's Kickoff Scramble

RTJ Oxmoor Valley (Ridge Course), Birmingham, AL

NOTICE TO COMPETITORS

The Rules of Golf as approved by the USGA and R&A effective January 1, 2019 and the local rules on both sides of this sheet govern play at this tournament. Disregard local rules printed on the club scorecard.

FORMAT, PLAYOFFS, AWARDS

Conducted at 36 holes of Scramble Stroke Play. Each partner of a side will start the play of each hole and then select one shot from the side and should mark the location. Each partner of the side plays their next stroke from within one club length of the selected location, no nearer the hole. This procedure is followed on every shot until a ball is holed.

If the selected location is within a bunker or penalty area, all strokes by the side must be made from within the same bunker or penalty area, unless relief is taken under an applicable Rule.

If the selected location is in the general area, the side may not use the one-club length allowance to place a ball on the putting green.

If the selected location is in a bunker, players may smooth sand and soil without restriction in the area in which a ball is to be placed.

A player may tap-in short putts prior to his/her partner playing from the previous location for the purpose of saving time.

Any ties for awards in all divisions and flights gross will be determined by a score card playoff using the USGA recommended tie-breaker method.

TRANSPORTATION AND CADDIES

a) Caddies are not permitted for this tournament. Disregard the Caddie/Spectator Cart Policy for this event.

OUT OF BOUNDS

Defined by inside edge of curbs on all public roads including the parking lot behind #9 green, entrance driveway, sidewalk right of #17 and #18; by the split-rail fence left of #17. A ball which crosses a public road defined as out of bounds and comes to rest beyond that road is out of bounds, even though it may lie on another part of the course.

RELIEF PROCEDURES

When the ball is in a position that either member of the side is entitled to relief, or the ball may be dropped in accordance with a Rule that provides penalized relief (i.e. Rule 17, Penalty Areas), if relief is taken it must be taken for all partners of the side. If the selected ball is in a position that is not entitled to relief, the side is not entitled to relief even if a ball put in play within one-club length would be entitled to relief.

OBSTRUCTIONS

- a) Stones and gravel adjacent to artificially surfaced cart paths are deemed part of the cart path.
- b) Birdhouses and their support posts, wave siren posts are immovable obstructions.
- c) Areas encircled by cart path adjacent to putting greens and wood rail fences when not located inside a penalty area are deemed part of the cart path.
- d) Ropes and stakes supporting newly planted trees are immovable obstructions. Relief is from the ropes and stakes, not the tree itself.

GENERAL

- a) Tees: Amateur Men 14-64; Professional Men: RTJ White
Amateur Females 14-50; Amateur Males 65+; Professional Women: RTJ Silver
Amateur Boys 13 & Under & Girls 14 & Under; Amateur Females 50+: RTJ Teal
- b) Scorecards must be verbally certified at the scoring area following play inside the clubhouse dining room.
- c) Pace of Play: See scorecard for specific Pace of Play times.
- d) Weather Evacuation: Players should proceed to the clubhouse in case of a suspension of play for a dangerous situation.
- e) Comfort stations and shelters: #5 green, #12 tee/#14 green, clubhouse
- f) Rules Committee: Jeremy Gardner, Brian Scheufler, Adam Powell

COURSE MEASUREMENTS:

1. Hole locations are measured from the front of the green along the line of play from the center of the fairway or teeing ground.
2. Yardage Adjust (i.e. +7/-5) is the yardage to add/subtract to any yardage indicators, i.e. sprinkler heads or permanent markers.
3. Yardage on scorecards are to center of the green. Yardage on sprinkler heads and permanent markers on course are to the center of the green.
