Championship History

This year marks the 103rd playing of the Alabama Men's State Amateur Championship and the sixth time that Turtle Point Yacht & Country Club has hosted the Men's State Amateur Championship (1968 Hubert Green of Birmingham, 1976 Richard Anthony of Birmingham, 1985 Tom Jones of Fort Payne, 1999 Payton Osborn of Birmingham, 2010 Hunter Hamrick of Montgomery). Matt Lorenz of Fairhope won the title in 2018 at Pine Tree Country Club. The Championship was first played in 1915 at Montgomery Country Club in Montgomery, AL. Jack Allison of Birmingham, AL defeated Norborne R. Clarke 13 and 12 to win the inaugural event. The Championship was not played in 1917-18 due to World War I. Format was changed from match play to stroke play in 1955.

Championship Registration

There will be a formal registration for all competitors in the clubhouse foyer (next to Golf Shop) on Tuesday, June 4 and Wednesday, June 5 from 9:00am-4:00pm. Please register to sign the host plaque and have your photo taken for website scoring.

Turtle Point Yacht & Country Club Policies (READ CAREFULLY)

Cell Phone Policy: Cell phones may only be used on the golf course in case of an emergency, to call the golf shop in need of a ruling, view tournament leaderboard or as a distance measuring device. We ask that phones are set to silent while on club grounds. Silent communications (text, email) may be used inside buildings. Verbal communication (phone calls) must be outside buildings.

Parking: There is a limited amount of parking available at the host club and we ask that players, caddies and family members car pool as much as possible.

Dress Code: Appropriate golf attire must be worn. Slacks or Bermuda shorts. No cut-offs, no denim, no cargo pants or cargo shorts. Men must wear shirts with collars and sleeves, tucked in at all times. Non-metal spikes only. Dress code applies to caddies and spectators.

Coolers: Personal coolers are not allowed.

Personal Items: Make sure not to leave any valuable personal items unattended such as jewelry, wallets, etc. even if they are tucked away inside your golf bag. It is best to leave your valuables locked in your automobile. Neither the AGA nor the host club will be held responsible for any lost or stolen personal items.

Accepted Forms of Payment: Club accepts cash, credit card and limited reciprocal.

Practice Rounds and Practice Facility

Official practice rounds will be on Tuesday, June 4 and Wednesday, June 5. You must call the golf shop (256-757-2155) to schedule your practice round(s) for these days. Make sure to identify yourself as an Alabama Men's State Amateur Championship participant. It would be helpful if you make your own group before calling. Do not just show up at the course and expect to be accommodated for a practice round. There is a mandatory \$30.00 fee for each practice round whether you walk or ride. Players are limited to playing one ball except from the teeing ground. Players are welcome to use the practice range and putting green throughout the championship.

Starting Times

Starting times for June 6-7 will be available on May 31 by 5:00pm. Check the AGA website at www.alabamagolf.org.

Championship Format and Schedule

- The field will be cut to the low 60 players and ties after 36 holes.
- The lowest score for 72 holes will be the Champion.
- In the event of a tie for the Championship, a three-hole aggregate play-off will be held immediately following play. The winner will be the player with the lowest aggregate score for the play-off holes. In the event of a further tie, play will immediately continue hole by hole until Champion is determined. The play-off holes and their order of play will be determined by the Committee.
- Initial groupings will be for two days; the field will be cut and re-paired by score after the second round.

Tuesday, June 4	All Day: Practice rounds. 9:00am-4:00pm: Player Registration in the Clubhouse Foyer adjacent to the golf shop.
Wednesday, June 5	All Day: Practice rounds. 9:00am-4:00pm: Player Registration in the Clubhouse Foyer adjacent to the golf shop.
Thursday, June 6	Round 1: Tee times begin at 7:30am & 12:30pm off #1 & #10 tees. 18 holes Stroke Play.
Friday, June 7	Round 2: Tee times begin at 7:30am & 12:30pm off #1 & #10 tees. 18 holes Stroke Play. Cut to low 60 scores and ties. Field re-grouped according to score.
Saturday, June 8	Round 3: Tee times begin at 7:30am off #1 & #10 tees. 18 holes Stroke Play. 11:00am-3:00pm: Hosted player lunch in the Clubhouse. Field re-grouped according to score.
Sunday, June 9	Round 4: Tee times begin at 7:30am off #1 & #10 tees. 18 holes Stroke Play. 11:00am-3:00pm: Hosted player lunch in the Clubhouse. Awards ceremony immediately following play at scoreboard.

Pace of Play

The AGA wants all players to enjoy competing in our events. Pace of play may differ depending upon the venue, weather and course conditions. Every player is accountable for playing at an acceptable pace, therefore we need your help. Please observe the following guidelines to help ensure a pleasant tournament experience for all:

- Make sure to keep pace with the group in FRONT of you. The group behind should keep pace with your group and so forth.
- Go directly to your ball. If sharing a golf cart, drop-off the player farthest from the hole then proceed to the other ball.
- Be ready to play when it is your turn.
- Keep practice strokes and time taken to read putts to a minimum.
- Play a provisional ball if your original ball may be lost or out of bounds.
- Keep time taken at the snack bar or between nines to a minimum.

If everyone does their part, then 4½ hours should be the maximum time taken to play a round of golf at an AGA tournament. Following the lead of the USGA, the AGA has developed a pace of play policy, based on Rule 5.6b and Model Local Rule 8K that is fair to every competitor.

*Note: a group may receive a "friendly reminder" of their position regardless of pace of play guidelines.

Maximum Allowable Time

The maximum allowable time is the maximum time considered necessary by the Committee for a group to complete its round. This is expressed in a per-hole and aggregate time format and includes all time associated with playing the game, e.g., for rulings and walking times between holes.

Both the specific maximum time allotted per hole and for the completion of 18 holes at AGA championships will be denoted on each player's AGA issued scorecard.

Cart/Range Fees; Push Carts

- *Practice Rounds:* Cart/range fees are not included in the entry fee. Cart rental is mandatory for practice rounds payable at the host club.
- *Championship Rounds:* Championship site cart/range fees are paid by the AGA and included in the entry fee. Competitors have the option to either walk or use a golf cart during championship rounds. Personal push carts are allowed.

Caddies

- *Caddies:* Caddies are allowed for sectional qualifying and championship rounds. Caddies will not be available at host club.
- *Caddie Cart Policy:* During the play of a hole, either the player or his caddie may ride in a golf cart but not both at the same time.
- Caddies are required to wear an AGA issued caddie bib at the championship proper.

Spectators

- *Spectator Golf Cart Policy:* Due to the limited number of available golf carts, spectator carts may not be available during the championship.
- *Disability Golf Cart Policy:* In consistency with the Americans with Disabilities Act (ADA), AGA will grant an individual with a bona fide disability a golf cart if the following conditions are met:
 - Requesting individual completes and submits a [Disabled Golf Cart Request Form](#) by the close of entries date;
 - Host club has a golf cart available;
 - Requesting individual pays host club the appropriate fee;
 - Requesting individual presents to the AGA staff or AGA representative a disability card issued by a government agency.
- Spectator carts must remain on the cart path at all times and spectators must adhere to the club's dress code policy.
- Spectators are not allowed to ride in a player's golf cart at any time. Non-club owned spectator carts are not allowed except as provided in the [AGA Tournament Manual](#).

Prizes

- *Sectional Qualifying Rounds:* Lowest Scorer for 18 Holes in each location: Silver medal; if a tie, duplicate medals will be awarded.
- *Championship:* Awards will be presented to the top three finishers. Merchandise prizes are awarded to the top finishers. Champion will have his name engraved on the *Sam Perry Trophy* and may take possession of the trophy for the ensuing year.
- Prizes in AGA amateur championships comply with USGA Rules of Amateur Status (see USGA Rules of Golf).
- High School or collegiate players should check with their institution compliance department regarding High School or NCAA regulations relating to accepting prizes or merchandise.

Exemptions Earned

- Champion receives a lifetime exemption into the Alabama Men's State Amateur Championship.
- Champion receives 10 year exemption into the Alabama State Match Play Championship (2019-2028).
- Champion receives 10 year exemption into the Alabama State Mid-Amateur Championship (2019-2028) (must be 25 years of age or older by first day of Championship).
- Players finishing in the top 30 (and ties) will receive an exemption into the 2020 Alabama Men's State Amateur Championship and 2019 Alabama State Mid-Amateur Championship (must be 25 years of age or older by first day of Championship).
- Players finishing in the top 16 (and ties) will receive an exemption into the 2019 Alabama State Match Play Championship.

Withdrawals

SECTIONAL QUALIFYING

Withdrawal (Montgomery qualifier): If an accepted player withdraws for any reason before the close of registration at **11:59pm on Tuesday, April 30, 2019**, the entry fee will be refunded, subject to a \$30.00 service fee.

Withdrawal (All other qualifiers and exempt players): If an accepted player withdraws for any reason before the close of registration at **11:59pm on Tuesday, May 14, 2019**, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted player withdraws for any reason after the close of registration and before the deadlines listed below for any reason, 50% of the entry fee will be refunded. No refunds will be made for withdrawals after the deadlines listed below.

CHAMPIONSHIP

Successful Qualifier Withdrawal: If a successful qualifier withdraws for any reason after paying his remaining championship balance of \$160 and before 11:59pm on Monday, June 3, 2019, 50% of the remaining championship balance (\$80) will be refunded. No refunds will be made for withdrawals after Monday, June 3, 2019.

Exempt Player Withdrawal: If an exempt player withdraws for any reason before the close of registration at 11:59pm on Tuesday, May 14, 2019, the entry fee will be refunded, subject to a \$30.00 service fee. If an exempt player withdraws for any reason after the close of registration and before 11:59pm on Monday, June 3, 2019, 50% of the entry fee will be refunded. No refunds will be made for withdrawals after Monday, June 3, 2019.

To withdraw from the event before the close of registration, follow these steps:

- 2) Sign In to your AGA Tournament Registration Account.
- 3) Click "Edit Registration" from left side of the page.
- 4) Choose "Cancel Registration" under dropdown menu on right side of page.

No Shows
